She alleged there was an agreement to split revenue from the show with the Museum because of their exceptional volunteer efforts. This could not be corroborated by Joe or Gloria. Joyce maintains that the future of the BB show is in jeopardy if we cannot agree to follow through with a co-sponsoring arrangement.
