Previous Meeting Minutes

Steve raised concerns about the accuracy of the grant application policy reflected in November's minutes.

Joe (and others) explained the proper procedural timeline for a request:

- 1) Applications are submitted between December 1st and September 1st.
- 2) Applications are reviewed between September 1st and November 1st.
- 3) Approved grants are remitted by November 30th.

Secretary's Note: This new timeline (which overrules the timeline of the previous meeting) was lifted directly from the recorded videoscript of the January meeting. A combination of Steve, Ed, Joe, Austin, Bill, and Joyce were discussing the proper timeline and this is what came out of it. Endowment Committee

The performance review is in the quarterly update.

There is another meeting in April.

Grant Application

The grant submitted by the Sea Scouts will be evaluated after receiving budget items from Joyce and Carmen.

2024 Budget Discussion

Jack Brooks explained the functionality of the endowment funds.

The Nautical Mile and chapter outreach are the main uses of the endowment funds. (Efforts to attract/retain members)

The endowment funds can also be used to cover emergency costs. (Extreme loss of membership revenue, chapter survival)

Budgets can be earmarked with endowment funds to help offset certain costs.

The range of use of these funds is between 2% and 7% per year.

The endowment funds were originally split into two pools:

- 1) The main body consisting of the majority of the money
- 2) A \$15,000 carve-out to use while the endowment fund itself began to grow on its own.

Ed said he was expecting the chapter to use portions of this carve-out to develop the chapter during the last three years.

Jack described how the endowment could be used to supplement our annual budgets.

Joe expressed his financial caution when it comes to using any of these funds during fiscally uncertain times.

Jack again explained how it may be more important to worry about the chapter's stagnation and loss of membership than holding down all the money.


Ed requested that the 2024 budget make use of the endowment funds to help hit goals more easily.

Brian reminded the meeting attendees of the budget committee which was created during the November 2023 meeting consisting of Joe Gartner, Steve Ingraham, Mark Marsilio, and Brian himself.

Bill asked about the status of a request he put in for the sea scouts last year. He expressed frustration about the bureaucracy of the chapter delaying fulfillment of its promises.

Ed and Dave apologized for the stalling of payments and reiterated that the Mid-Atlantic Chapter may be slow, but we are trying to iron out the process of approving grants so that future funding may flow more smoothly.

Ed promised an answer before the next board meeting and hopefully within the next month on this grant funding matter.
